# About the College

A single faculty college affiliated to the University of Mumbai, the college received an ‘A’ grade in September **2002** by the **National Accreditation and Assessment Council (NAAC)**. In January **2008** the college applied for re-accreditation under NAAC and was awarded an ‘A’ grade with a CGPA of **3.46**. In January 2013 the college was awarded an ‘A’ grade with CGPA of **3.72**, the highest in India as of now. The College has been recognized by the UGC as a College with Potential for Excellence in 2016.

The **mission** of the college is to develop leaders with a heart who are inquiring, intelligent, sensitive and empathic learners, committed to learning and who embody strong personal values. The college adopts a holistic approach to inculcate community service and responsible citizenship in the students by encouraging participation in social, cultural and sports activities along with academic rigour. The college has introduced several new post graduate and under graduate programmes in the last five years.

# Student-Centric Learning

A host of instruction methods are deployed to make teaching-learning holistic and effective.

H.R. College believes in the policy stated by Phil Collins - “In learning you will teach and in teaching you will learn”, and hence the instructional paradigm has shifted from a teacher-centered model to a learner-centered approach shown below. The college has clearly perceived that student-centered methods have proved to be superior to the traditional teacher-centred approaches. The learner-centric approach facilitates critical thinking and creative problem-solving skills among students.

The **student-centric** model leads to student empowerment. The students on their part assume more responsibility of learning. Active learning is achieved by the introduction of interactive methods such as project work, class assignments, group work, and working in pairs, role play, brainstorming and use of case studies. The student-centric model adopts various strategies that help students acquire life skills, knowledge management skills and lifelong learning.

Some of these strategies are:

- Introduction of **Certificate Courses** like MicroMBA, Luxury Brand Management, Equity & Derivatives Markets and Certified Capital Markets; besides Summer Schools and Corporate Seminars which cover a wide range of dynamic courses reflecting emerging trends.
- Organizing **Distinguished Lecture Series** where professionals from leading organizations deliver lectures in the college and educate students on the dynamics of the real world i.e. Seminar on Big Data, Business Intelligence & Analytics; Panel Discussion on Goods and Services Tax; and Seminar on Budget Analysis.
- Creating Partnerships with industry, NGOs and other stakeholders to bring communities to the classrooms.
- Instituting state-of-the-art infrastructure and modern teaching learning methodology to make knowledge acquisition effective.
- Encouraging students to undertake internships to acquire a hands-on learning experience.
- Training faculty in developing student-centered teaching learning techniques. Several training programmes have been organized like the “Competency Hexagon to lead the 21st century student”, “Craft of Teaching” & “Teaching Pedagogy”.


The feedback from various stakeholders is monitored closely by the Core Committee.

## COLLEGE MAGAZINE



## GRADES OF CERTIFICATE

The Higher Secondary Certificate shall be awarded by the state board in four grades as shown below:

<b>Grade I</b>	<b>60% - up to 75%</b>
<b>Grade II</b>	<b>45% - up to 60%</b>
<b>Grade Pass</b>	<b>35% - up to 45%</b>

# Examinations

## FOR F.Y.J.C.

Four examinations are held in the course of the academic year:

1. **Unit Test** (25 marks each subject) is held in the month of August.
2. **Terminal examination** (50 marks each subject) is held at the end of the first-term.
3. **Unit Test** (25 marks each subject) is held in the second-term.
4. **Annual Examination** (80 marks +20 marks internals/practicals) is held in the month of March/April.

Re-examination of First Terminal and Annual examination is conducted as per the rules of the HSC Board and with prior permission of the Principal. The detailed schedule of the respective examinations will be put up on the notice board from time to time.

## FORS.Y.J.C.

**Two examinations** are held in the course of the academic year:

1. **Terminal examination** is held at the end of the first-term.
2. **The Preliminary Examination** is held in the month of January. The portion, pattern and duration of the examination will be the same as prescribed by the Board for the H.S.C. examination.

## HSC Board Examination

The HSC exam (Higher Secondary Certificate Examination) is held under the aegis of the Maharashtra State Board of Secondary and Higher Secondary Education in February/March.

## RULES OF PROMOTION - F.Y.J.C. ANNUAL EXAMINATION

The rules of promotion are as under:

1. Minimum marks for passing in a subject will be 35%.
2. There shall be no concession of A.T.K.T. at the F.Y.J.C. level. It is mandatory to pass in all eight subjects.
3. The result of the First Year of Junior College (Std. XI) class will be decided on the marks obtained in all the examinations held during the academic year. According to the prescribed standards of evaluation, equal weightage will be given to:
  - (a) Unit test
  - (b) Terminal Examination
  - (c) Unit Test
  - (d) Annual Examination

The Final result of the student will be based on the average marks scored in all four exams.

4. There shall be no re-examination in the case of students who have failed.
5. If a candidate appearing in all the subjects and fails in one or more subjects, his deficiency of marks in maximum 3 subjects to a maximum of 15 marks but not exceeding 10 marks in any one subject, shall be condoned for the purpose of passing the examination.

## COPYING OR USING UNFAIR MEANS

If a student is found copying or using unfair means in any examination, and the unfair means committee after enquiry finds him/her guilty, strict disciplinary action will be taken and the performance of such a student in the entire examination, including the paper/subject, if any, for which the student has already appeared, shall be treated as null and void, and for the purpose of the computation of the final result, the students shall be treated to have scored "zero" marks in each of his/her papers/subjects at the examination, and shall not be eligible for re-admission in this college.

## ADMISSION TO THE EXAMINATION HALL

- 1.a Every candidate admitted to the Higher Secondary Certificate Examination shall be given an 'Admission Card - Hall Ticket' by the Divisional Board and the candidate shall be required to produce it every day of the Examination to the Conductor of the Examination at the centre. The centres assigned to the candidates are near/around the area of their college and not their residence.
- 1.b The Admission Card shall be issued to the candidate before he/she appears for the Examination on behalf of the Divisional Board by the Head of the Junior College and signed by the candidate in the presence of the Head of such Junior College.
- 1.c If, for any reason, the candidate fails to produce such Admission Card or the Admission Card produced does not bear the candidate's signature attested by the Head of the Junior College, the Conductor may allow the candidate to appear for the Examination only after satisfying

himself/herself as to the candidate's identity by making enquiries to corroborate the information available to him from the list of candidates.

- 1.d The conductor shall issue to the candidate a permit signed by him, to be presented by the candidate on subsequent days of the Examination.
- 1.e In case, where the candidate's signature, if taken in the Examination Hall, does not tally with that on the Admission Card, the candidate shall be liable to be refused permission to appear for the Examination.
2. No candidate shall be admitted to the Examination Hall if he / she arrives at the Examination Hall late by more than half an hour after the time fixed for the starting of the paper.
3. No candidate suffering from any infectious or contagious disease shall be admitted to the Examination Hall. If any such case is brought to the notice of the Conductor of the Examination, he will make separate arrangements for his / her seating.

### **ELIGIBILITY OF REGULAR CANDIDATES TO APPEAR FOR THE EXAMINATION**

A candidate attending the Second Year of Junior College class shall be eligible to appear for Higher Secondary Certificate examination to be held at the end of the Second Year of Junior College on fulfilling the following conditions:

- 1.a In case of February or March examinations, he / she should have attended the final standard of one or more recognized Junior college for not less than 75 per cent of the working days, separately in two different terms.

Provided that, a candidate who does not fulfill the requirement of the minimum attendance of 75 per cent separately as stated above, and whose deficiency is not condoned and who is thus not admitted to the examination or whose very application for admission to the examination is not forwarded by the Head of the Junior College on account of likely deficiency in attendance or whose application was withdrawn, shall make up the deficiency in attendance, either:

- (i) during the first part of the next academic year, if he/she intends to appear for the examination in the following October or November

**OR**

- (ii) during the first or second or both parts of the next academic year, if he /she intends to appear at the examination in the following March or April.

- 1.b The Divisional Chairman, may, for special medical reasons or circumstances beyond the control of the candidate as certified by the Head of the Institution or suo-moto, condone a deficiency in the percentage of attendance prescribed under clause (a) above, up to 15 percent.

The Divisional Chairman, may on the merit of the case condone such deficiency either in Part I or Part II or in both the parts separately, provided that, the Divisional Chairman on recommendation of the Head of the Junior College concerned

may condone deficiency in attendance beyond 15 per cent, in respect of a student who represents India or Maharashtra in any International, National or Inter-State Sports or games held in India or abroad to the extent the student is required to remain absent from the Junior College for such participation.

- 1.c The Head of the Junior College concerned, shall withdraw on or before the date prescribed therein, forms of application forwarded to the Divisional Board's office in respect of those candidates who do not fulfill the conditions laid down under provision to clause (a) above, unless the deficiency in attendance is condoned by the Divisional Chairman in cases referred to him by the Head of the Junior College on or before 20th February or 20th September as the case may be with statement of attendance of each such candidate in the form prescribed by the Divisional Board.
2. The Head of the Junior College has certified that:
  - (a) he has kept the prescribed attendance as laid down under Clause (1) (a) above.
  - (b) to the best of his knowledge, the candidate is a fit person as regards character for admission to the examination. Where in the opinion of the Head of the Junior College, the character of any candidate is not good, he shall nevertheless forward the application of the candidate to the Divisional Board, after endorsing thereon the reasons for forming such opinion, with the instance (if any) in support thereof. All such applications shall be considered by the Standing Committee which shall, on merits of each case, decide whether the candidate be permitted to appear at the Examination or not, and the decision of the Standing Committee shall be final.
3. Every candidate attending the Second Year of Junior College Class, if he / she makes a proper application to the Divisional Board for appearing at the Examination, if he / she satisfies the condition laid down regarding attendance and completing practical work (if any) and if the Head of the Junior College certifies that he / she is a fit person as regards character, for admission to the examination or where such a certificate is not given, the Standing Committee decides that the candidate be permitted to appear at the Examination, then such a candidate shall have the right to be admitted to and to appear for the Examination.
4. Where a proper application is made by the candidate to the Divisional Board for appearing at the Examination, and the conditions regarding attendance and completing practical work (if any) are satisfied, the application shall not be withheld by the Head of the Junior College on any other ground.
5. Every candidate (whether private or regular) shall abide by the instructions which the Divisional Board may, from time to time, issue through the Heads of Junior Colleges regarding submission of application forms, admission to the Examination Hall and discipline during the course of the Examination. Any breach of such instructions will render a candidate liable for action.

# Student Documents Info

## IDENTITY CARD

After admission, each student will be given a Identity Card, to which he/she must affix his/her photograph and obtain the signature of the Principal. They will not be allowed to enter the college premises without their Identity Card.

Loss of Identity Card should be reported to the College Office in writing without delay with a statement of the circumstances in which it was lost. The Student should then apply for a duplicate Identity card.

## RAILWAY CONCESSION

All students (male students below 25 years and all lady students) are eligible for concession on railways for local journeys between the stations nearest to the place of their residence in Mumbai and the College (Churchgate/CST). As per the railways rules, students cannot avail local concession (after the annual examination) when lecture or assignment are not in progress.

Long journey Railway concessions will be granted during vacation only for journeys between their place of permanent addresses as per the rules published by the Railways. The place of permanent residence, in the application for admission means the place where the student and / or his parents normally reside. This address will not be allowed to be changed during the academic year, unless there is a change of residence which has to be intimated to the office. Forms for above concessions are available at the College office.

The counter is open MONDAY to FRIDAY 9:45am to 12:15pm & 12:45 to 5.00pm.

## TRANSCRIPTS

Students desirous of pursuing further studies abroad should apply for transcripts along with necessary fees to the Transcript counter well in advance. After verification of original marksheets and other relevant papers, the college will hand over the transcripts / Recommendation Letter in ten working days.

The Transcripts counter is open MONDAY to FRIDAY 9:30am to 1:00pm and on 1st & 3rd Saturdays of the month 9:30am to 1:00pm



# Admissions

- One photo copy of the First & the Last Page of Ration Card (For girls applying for government freeship-staying in Maharashtra for more than 15 years and up to the third child)

### FOR ICSE/CBSE STUDENTS

- Admission form
- Original mark sheet + 3 attested photo copies
- Original Passing Certificate + 3 attested Photo copies
- Original School Leaving Certificate/Transfer certificate+3 attested photo copies
- Original Migration Certificate +2 attested photo copies
- Original Character Certificate +2 attested copies
- Transcript/ Syllabus of passed subjects (1 copy)
- Deed of Undertaking on Rs.100/- Stamp paper (Matter pinned with the application form for eligibility as in point Number 2)
- One photo copy of the First & the Last Page of the Ration Card (For girls applying for government freeship - staying in Maharashtra for more than 15 years and up to the third child)

**Note:** 2 photo copies should have original signature of the principal and not rubber stamp signature.

## ADDITIONAL INFORMATION

- The student must affix his recent photograph on the admission form and have 3 more copies of the photograph with him for the identity card and other purposes.
- He / She will have to pay the fees on the day of admission to F.Y.J.C. Class.
- Applications of students of this college for admission to S.Y.J.C. must be accompanied by (i) Identity Card of F.Y.J.C. and (ii) Progress Report showing promotion to the S.Y.J.C. Class.



## ELIGIBILITY

Students who have passed the public examination of the Statutory Boards, recognised bodies outside Maharashtra State will have to produce the following documents for eligibility purpose:

1. Eligibility form with one photograph attached.
2. 1 photocopy of attested mark sheet
3. 1 photocopy of Passing Certificate
4. 1 photocopy of School Leaving Certificate / Transfer Certificate
5. Original Migration Certificate
6. Deed of undertaking

The Divisional Secretary shall issue Eligibility Certificate on receipt of the above documents. If for any reason the Divisional Secretary does not issue the Eligibility Certificate then the student will have to withdraw his admission.

## MIGRATION CERTIFICATE FOR ADMISSION

A migration Certificate from any other statutory Board, recognised body or university conducting the examination passed by the candidate shall have to be produced by candidates coming from other states and seeking admission to first year or second year of a Junior College.

### NOTE:

- a. Students are advised in their own interest, that before submitting certificates, mark sheets etc. in the original to the College office, they should retain true copies of the documents with themselves.
- b. **The Original School Leaving Certificate or Transference Certificate will be kept by the College permanently and under no circumstances will it be given back to the students. Hence, students should keep sufficient number of photo copies of School Leaving or Transference Certificates with them.**
- c. If both the standards i.e. the First Year Junior College and the Second Year Junior College are attached to the same college, admission fees will be charged only once at the time of admission of a student to any one of these standards.
- d. Eligible students can avail of freeship by submitting of photo copy of first and Last page of Ration Card.

## ACADEMIC YEAR (THE TWO TERMS)

The Academic year is divided into two terms with a Diwali Break and winter break between the two terms. The exact dates will be notified as soon as received from the Deputy Director of Education.

The College will be closed on Sundays and Public Holidays declared by the Government and on such days as the Principal may declare from time to time.

## MODE OF REFUND OF FEES

- (a) If a student informs the institution before the commencement of the academic year that he wants to withdraw and he cannot continue his education in the same institution for any reason, the institution concerned should refund the tuition fees, term fees, laboratory fees (if any) and Library and Laboratory deposits, if any, actually recovered from the student in full. The admission fee may however, be retained by the Institution.
- (b) If a student desires to withdraw and applies for refund of fee after the commencement of the academic year, the institution concerned should retain the admission fee, term fee and laboratory fee (if any), in full and also the proportionate amount of the tuition fee till the end of the month in which the refund is claimed. The remaining amount of tuition fee, if any, will only be refunded. The library deposit and laboratory deposit should also be refunded (For example, if a student applies for refund of fees in the month of July after the academic year has started, he will be entitled for refund of proportionate amount of tuition fees only for the subsequent months, i.e. August onwards, if the tuition fee has been recovered on term basis, and the institution will retain the proportionate amount of tuition fee for the month of June and July only. If however, the tuition fee is recovered on monthly basis the student will not be entitled for any refund of tuition fee for and up to the month of July paid by him. In both the cases, the entire amount of admission fee, term fee and laboratory fee if any, may be retained by the institution. The library deposit and laboratory deposit if any, should however, be refunded in full).



## HR OFFICE

- The office is located on the Ground floor of the college building.
- The office timings are from 9.00 am to 5.00 pm - Monday to Saturday
- Concession forms available from 9.30 am to 12.00 noon and from 12.30 pm to 4.00 pm.
- Payments are accepted from 9.30 am to 12.30 pm except on Saturdays.
- All queries will be addressed at the Enquiry Counter.
- All forms must be presented personally by the students to avoid delays.

# Code of Conduct and College Regulations

---

- Students joining the college are strictly bound by the Rules and Regulations of the college.
- Every student must obtain on admission, and keep his/her Identity Card affixed with photograph, duly attested and present it for inspection on demand.
- Students must attend lectures and tutorials according to the timetable on all working days of the College. Students should not be absent from lectures, tutorials and examinations without prior permission of the Principal. **Students are warned that if their attendance at lectures and tutorials is unsatisfactory, their names may be struck off the college rolls/or may be detained from the examinations.**
- In case of illness, a student must apply for leave, as soon as possible, with a doctor's certificate. He/She must personally report to the Prof. In-charge / Vice Principal on resuming class.
- Students must not attend classes other than their own without the permission of the Principal.
- Smoking is strictly prohibited in the College premises.
- Students shall do nothing either inside or outside the College that will in any way interfere with its orderly conduct and discipline.
- No Society or Association can be formed in the College and no person invited to address a meeting without the Principal's prior permission and sanction.
- No student shall collect any money or contribution for picnic, trip, educational visit to some place, get-together, study-notes, charity or any other activity without prior sanction of the Principal.
- No student will be allowed to take active part in current politics.
- No student shall communicate any information or write about matters dealing with the College in any manner to the Press or Media.
- Students are expected to take proper care of college property and to help in keeping the premises neat and clean. Causing damage to the property of the College, e.g. disfiguring walls, doors, fittings, or breaking furniture, etc., is a breach of discipline and the guilty will be duly punished.
- The College is not responsible for lost property. However, students may approach and inform the Vice Principal for the lost property to find out, if it is deposited in the College Office.
- Students applying for certificates, testimonials, etc. and those requiring the Principal's signature on any kind of documents or applications should first contact the College office. Students should bring no paper directly to the Principal for his/her signature.
- If, for any reason, the continuance of a student in the College, is, in the opinion of the Principal, detrimental to the best interest of the College, the Principal may ask such a student to leave the College without assigning any reason for his/her expulsion.
- Insubordination and unbecoming language or misconduct on the part of a student are sufficient reasons for his/her suspension or dismissal from the college.
- Students receiving Government or College Scholarships or any remission in fees, must note that the grant and continuance thereof are subject to good behaviour, regular attendance and satisfactory progress and good results at College and Board or University Examinations.
- All College activities must be organised under the guidance and supervision of the Principal and Professor In-Charge with prior permission only.
- Students must not associate themselves with any activity not authorised by the College Principal. Serious view will be taken of students found organising or participating in such unauthorised activities.
- Students using unfair means at examinations will not be readmitted to the College.
- It is the responsibility of the student to read the notice boards regularly for important announcements made by the College authorities from time to time. They will not be excused or be given any concession on grounds of ignorance.
- Use of cell phones is banned inside the college premises. Defaulters are liable to be punished.
- Students are prohibited to use college name to any private or individual event. Violation may lead to permanently debarring such students from the college.
- Matters not covered under the existing rules will rest at the absolute discretion of the Principal.
- The College prohibits any conduct by any student or students which has effect of teasing, treating or handling with rudeness a fresher or any other students or indulging in rowdy or undisciplined activities. Ragging is totally prohibited in Institution & anyone found guilty or ragging and/or abetting ragging, whether actively passively is liable to be punished in accordance with the regulations.

# Anti-Ragging Policy

The college has a zero tolerance policy towards ragging. The college conforms with all the guidelines on Anti-Ragging issued from time to time.

H.R. College has a fully functional 'Anti Ragging Squad'.

## WHAT CONSTITUTES RAGGING?

Ragging constitutes one or more of any of the following acts:

- a) Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student.
- b) Indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
- c) Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student.
- d) Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher.
- e) Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- f) Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students
- g) Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
- h) Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.
- i) Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.
- j) Any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of colour, race, religion, caste, ethnicity, gender (including transgender), sexual

orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background.

## MEASURES FOR PROHIBITION OF RAGGING

- The institutions shall take action in accordance with these Regulations against those found guilty of ragging and/or abetting ragging, actively or passively, or being part of a conspiracy to promote ragging.
- The application for admission, enrolment or registration must be accompanied by an Anti Ragging affidavit signed by a student in a prescribed format and another Anti Ragging Affidavit signed by a Parent/Guardian. (Both these Affidavits can be downloaded from [www.antiragging.in](http://www.antiragging.in) or [www.amanmovement.org](http://www.amanmovement.org))

## ADMINISTRATIVE ACTION IN THE EVENT OF RAGGING:

The institution shall punish a student found guilty of ragging after following the procedure and in the manner prescribed here in under:

- a) Suspension from attending classes and academic privileges.
- b) Withholding/ withdrawing scholarship/ fellowship and other benefits.
- c) Debarring from appearing in any test/ examination or other evaluation process.
- d) Withholding results.
- e) Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- f) Suspension/ expulsion from the hostel.
- g) Cancellation of admission.
- h) Rustication from the institution for period ranging from one to four semesters.
- I) Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.

# Student Support

Records show that students involved in the Grade Improvement Programme respond positively to the College's efforts.

## INTENSIVE AND REMEDIAL TEACHING

### Intensive Coaching

At H.R. College we believe that diligence, seasoned with the right amount of smartness, can ensure brilliant results at the examinations. Therefore Intensive Coaching Sessions are organised keeping the following objectives in mind.

- To help students to not only study hard but also to study smart
- To help students adopt a more productive and effective approach to the learning process.
- To support students with additional learning material and library books
- To generate confidence among students and enable them to believe in themselves

Students in the intensive coaching batches are given the benefit of internal as well as external faculty to facilitate comprehensive grasp of the subject. The sessions have examination-oriented approach, topics are discussed and the main points are summarised at the end of the discussion. It is impressed upon the students that the technique of writing answers in the prescribed time limit is what sets apart the toppers from the rest. Hence full practice is given in solving test papers which are then evaluated by internal and external examiners.

### Remedial Teaching

The HR College also conducts special classes for students with latent potential. Topics which students find difficult are taught again and even the slightest doubt is cleared with great patience.

### Special Cell

“A Platform for addressing the special needs of the students,” is how the Special Cell of HR College defines itself and its existence.

The objective of the Special Cell is to provide students a support in overcoming dyslexic, learning and other learning deficiencies. The Cell creates a platform for these young adults to prove their mettle and creates a marked difference to their lives.

## FIRST DAY BROCHURE

This is given to the first year students. The dates of the Orientation and the commencement of lectures are given. It also provides college details, the calendar of events, faculty list and the email ids of teachers teaching various subjects. It gives course work information: syllabus, prescribed books, reference books, learning objectives, details of internal assessment, the topics for the tests and the projects, project guidelines, paper patterns for the semester end examinations, sample MCQs, sample question papers and lecture plans for every subject.

## STUDENT COURSE PACKS

The course pack is a specially compiled booklet which is given to the students for self improvement, self learning and self evaluation. The course pack covers suggestions on handling the course, broad outlines of the class lectures, powerpoint presentations, notes on important topics, practical examples and mock questions.

## TEACHING & LEARNING MATERIALS CENTRE

The Teaching & Learning Materials Centre (TLMC) is a curriculum laboratory which provides resources aimed at improving the teaching and learning process. The TLMC has activity guides, simulation games, instructors manuals, examination guides, cassettes, slides, curriculum guides, multimedia kits, video discs etc.

## OPEN FORUM

The **Open Forum** is yet another step by the Council to ensure students' welfare and is organized mainly to oversee any complaints, feedback and grievances. **Enactus** is a community of student, academic and business leaders committed to using the power of entrepreneurial action to transform lives and shape a better and more sustainable world.

This student organization works with different communities at the grass root level and develops sustainable business models for them. Enactus acts as a catalyst for converting every student into a socially responsible business leader of tomorrow.

**Project Aajeevika:** Enactus H.R. College launched its flagship project, with the aim to provide employment opportunities to the rural women of Maharashtra by capitalising on their indigenous skills, thus an attempt to improve their livelihood. The women stitch canvas tote bags which are available in varied trendy designs.

### Project Inaayat:

Inaayat is in collaboration with an international organisation Days for Girls. Inaayat is dedicated to strengthening girls' sense of dignity and self-esteem by making and providing sustainable menstrual hygiene solutions and health education.

Enactus conducted a campaign called #PassThePad where girls and women were encouraged to use the eco-friendly cloth pads instead of disposable plastic pads which increase pollution.

## Project Jalvrudhhi

Project Jalvrudhhi is dedicated to revolutionize the manner in which water has been transported and utilized by the houses of rural India since the olden times.

As a solution to the problem of water transportation, the villagers were provided with the water wheel which is a 45 litre rolling drum manufactured by Wello. It is durable, easy to use and efficient to use. Wockhardt Foundation's 'Shuddhu purification pills' were also distributed to tackle the problem of water purification.

Recently the project was expanded to Shegaon, located at the frontier of Maharashtra. To be able to provide the water wheel at a feasible price, a cross subsidy model was devised by engaging another set of rural women in a revenue-generating process. The profits of which are then used to subsidise the packages.

## INTERNAL COMPLAINTS COMMITTEE

The college has constituted an Internal Complaints Committee under the University Grants Commission (Prevention, Prohibition and redressal of sexual harassment of women employees and students in higher educational institution) Regulations 2015. The purpose of the Act is to protect women employees and student in higher educational institution against sexual harassment for the prevention and redressal of complaints of sexual harassment and for matters connected therewith or identical thereof. Any complaint regarding sexual harassment is to be made in writing to the ICC within 3 months from the date of incident or within 3 months from the date of last incident in case of a series of incidents.

# Enrichment Activities

## OPEN HOUSE

A unique platform for a dialogue between parents, students and teachers. The Open Houses are held periodically to provide opportunity to parents to interact with the Principal and teachers and get first hand progress reports of their wards. HR recognises the fact that students undergo a major change in their career as they come out of school and enter Junior College where the environment is of self-discipline. Naturally every parent is interested to know how his/her ward has adapted to this change. HR invites parents to visit the college periodically and provide an opportunity to interact with the teachers, and get a feedback. A Teacher is assigned as a mentor to the students.

## GRADE IMPROVEMENT PROGRAMME

This is a unique programme initiated at Junior College for the students with the aim of enhancing their grades in SYJC. These students are identified on the basis of their FYJC annual results. A preliminary meeting of these students, their parents and teachers is organized. Extra examination and tests are conducted for these students and a relationship of “mentor and mentee” is built and maintained between these students and teachers.

## PHYSICAL TRAINING, GAMES & SPORTS

Sports, an important component to all-round development, is a must for every successful student. The College encourages student participation in sports at all levels - Local, National and International. The college invites coaches in different areas for physical training and fitness of the students. Training is given on Campus or at selected venues with appropriate amenities for the respective sports.

Activities covered are : Indoor games. Table Tennis, Badminton, Chess, Carom, Football, Cricket, Swimming, and Skating. All interested students should contact our Sports Director for further information.

## WOMENS DEVELOPMENT CELL

The Womens Development Cell (WDC) aims to promote awareness on gender equality and gender sensitization in the society and among students in particular. Towards this end, the students are encouraged to undertake various research projects, participate in debates and awareness campaigns. In keeping with the goal of women empowerment, the cell conducts self defense programmes for girl students and operates a Grievance Cell for urgent and effective handling of any gender related issues.

The Cell aims in particular at sensitizing the student community to issues relating to the female gender. # Library

The Library of H.R. College supports the mission of the college and is committed to providing information leading towards **excellence in commerce and business education**. It endeavors to help students to gather **multi-faceted knowledge** and thereby facilitate the process of **knowledge revolution** and overall **holistic personality development**.

It is located on the **first floor** offers an **air-conditioned Solar Reading Room** with seating capacity for 140 students. Besides this, a special room which accommodates about 60 students is kept open as additional reading space. It remains open **24 X 7** throughout the year. The **Open Access Collection** facility is offered from 8.00 a.m. to 6.00 p.m. on working days.

The library has a collection of **more than 58000 books and 67 periodicals**. It also has a collection of more than **850 Audio-Visual materials**. Library subscribes e-resources like NLIST, Ibl, JGate, CBME- books. The Library is **Fully Computerised** and collection details can be accessed with “**Any Word Anywhere**” facility via **SLIM21** - an integrated, multi-user, multi-tasking library information Windows based software.

The Library conducts **Orientations, Research Guidance Sessions, Book Exhibitions, Book Talks, Library Volunteerism Programmes** etc. on a regular basis.

## **LIBRARY RULES:**

Every bonafide student of this College may become a member of the library. **No Library Fee** is charged. A Library Borrower's Card is issued to each student on submitting **the identity card, a photograph and the First Term Fee Receipt**. Library follows “**One Id Card**” system. Every user can borrow **two books per week** for home lending and one book/non book at a time for Reference Reading. If a borrower damages/loses the book he/she shall have to replace the book. If it is not available in the market then the borrower shall have to pay the market price plus replacment charges.

The **charges for overdue books** will be Rs.1.00/day for first overdue week, Rs.2.00/day for second overdue week and Rs.5.00/day for next period of overdue. For reference books the fine would be Rs.5.00/day.

The library is a **Silent, No Mobile, No Eatables Zone**. Defaulters will be fined as per the university guidelines. The membership of the library will be cancelled immediately if a person is found guilty of violating willfully the rules and regulations of the library.

At the end of the second term all books must be returned to the library. However by special provision, books would be issued during examination period. The Librarian will issue a '**No Due Certificate**' to borrower who has cleared his/her account. This is necessary for obtaining the refund of Student Deposit from the College Office.
